The Fairfax County Arts Committee is an inter-agency and nonprofit partners group dedicated to realizing the County's strategic planning vision. Established in 2009 following adoption of a **VISUAL AND PERFORMING ARTS POLICY** in the Comprehensive Plan, the Committee has advanced the role of the arts in making Fairfax County a better place to live, work and play throughout its many diverse neighborhoods.

In the pages ahead, the 2024 accomplishments and project milestones are described in the context of the Countywide Strategic Plan and One Fairfax Policy. The work undertaken this and every year by agency and partner stakeholders is informed by the County's commitment to equity, alignment of community outcome goals and indicators of success, data-driven insights and inclusive engagement strategies.

As described in the Fairfax County Strategic Plan, outcome areas necessarily overlap in the ways that community needs are identified and addressed. For ease of understanding, the efforts described in this report are focused on and referenced in the "Cultural and Recreational Opportunities" outcome area. FAIRFAX REGIONAL ARTIST SURVEY

With funding from the National Endowment for the Arts and a private foundation, ArtsFairfax launched an **ARTIST SURVEY** to assess the opportunities and resources that local artists need to thrive. Open from May through December 2024, the survey is available in English, Spanish, Korean, Hindi and Farsi, and will help identify the needs and obstacles for artists who live or work in Fairfax County, its incorporated towns (Herndon, Vienna and Clifton), as well as the Cities of Fairfax and Falls Church.

MCLEAN PROJECT FOR THE ARTS EXPANSION

McLean Project for the Arts (MPA) will acquire space in downtown McLean through the **OFFICE OF SUPERVISOR JAMES BIERMAN** and the Department of Economic Initiatives. **MPA PROPOSED ACQUISITION** and build out of the ground floor retail space (approximately 5,000 square feet) at The Signet at 6910 Fleetwood Road, McLean, Virginia. The Board of Supervisors approved the allocation of \$500,000 from the Economic Opportunity Reserve for the effort on September 24, 2024.

CAPITAL ONE HALL • COMMUNITY ARTS PARTNERSHIP

From September 2023 to June 2024, Capital One Hall hosted 39 community events representing diverse cultural perspectives and art forms. This season was marked by remarkable growth in attendance and ticket revenue for community arts partners:

• Main Theater Ticketed Events: 23 (20 in Season II)

Total Attendance: 15,908 (52% increase from Season II)

• The Vault Ticketed Events: 16 (15 in Season II)

TICKET AND ENROLLMENT SUBSIDIES FOR ARTS PARTICIPATION

ArtsFairfax continues to grow collaboration between Fairfax County human services agencies and nonprofits through their **TICKET AND PARTICIPATION SUBSIDY GRANT**, which subsidizes attendance and participation access, and transportation needs to provide arts experiences for underserved populations.

ArtsFairfax awarded 20 Ticket and Participation Subsidy Grants, a jump from nine awards in the same category in FY23. Through this grant program, benefits and those involved include:

- 2,100 Fairfax County residents received free or reduced-price tickets (3.5 times more than in 2023).
- 39 Community Partners, including human services nonprofits and Fairfax County agencies.
- 8 Fairfax County Public School communities.

SUPERVISOR PALCHIK: PROVIDENCE ARTS ROUNDTABLE

With ArtsFairfax, Supervisor Palchik hosted an "Arts Roundtable" on July 10, 2024. More than 30 individual artists, local nonprofit groups and arts businesses, as well as civic leaders and representatives from County agencies, attended. ArtsFairfax facilitated a discussion around four pillars: space, promotion, funding and partnerships. The information shared and gathered will help inform how the County can support deeper arts engagement in the Providence District. ArtsFairfax intends to replicate the event to conduct Arts Roundtables in other districts.

SUPERVISOR JIMENEZ: MASON ARTS ADVISORY COMMITTEE

With support from Supervisor Jimenez and the Mason District office, the Mason Arts Advisory Committee was established with the goal of advancing Mason District as an arts and culture destination, and to serve the district's artists through effective implementation of the "Master Arts Plan: Facilities" and other activities.
